



# OKLAHOMA VOTER REGISTRATION APPLICATION

You may use this form in Oklahoma to:

- Register to vote.
- Change your residence or mailing address.
- Change your name for voter registration.
- Change your political party.

**WARNING:** All answers on this application must be true. It is a felony to submit false information on this form. You can be prosecuted if you do. If you are convicted, you can be imprisoned for not more than five years, fined not more than \$50,000, or both. (26 Okla. Stat. § 16-103.1)

## IMPORTANT INFORMATION

**Voter registration is closed for 24 days before an election. If you apply when registration is closed, your application will be processed when registration reopens after the election.**

- Mailed applications must be postmarked no later than 25 days before the election in which you wish to vote.
- You cannot vote until your application is approved by your local county election board. When it is approved, you will receive a voter identification card in the mail.
- If you do not receive a voter identification card within 30 days, contact your local county election board.
- If you have questions about registering to vote, contact your local county election board or visit the State Election Board website at <https://oklahoma.gov/elections>.
- Voter registration records are subject to public disclosure under the Oklahoma Open Records Act, Title 51 O.S. §§ 24A.1-29.

## INSTRUCTIONS

**SECTION 1 – ELIGIBILITY** Answer the two questions at the top of the application. If you answer NO to either question, DO NOT sign or submit this form.

**SECTION 2 – NAME** Provide your name.

**SECTION 3 – DATE OF BIRTH** Provide your full date of birth.

**SECTION 4 – IDENTIFICATION NUMBER** Your registration cannot be completed without a current and valid identification number. You must include:

- Your Oklahoma driver license/State ID card number, OR
- The last four digits of your Social Security number.

**SECTION 5 – POLITICAL PARTY**

- If you register in a political party recognized in Oklahoma, you may vote only in that party's primary elections.
- All registered voters may vote in general elections, regardless of their party affiliation.
- Independent (no party) voters generally may not vote in party primaries. However, every two years, political parties may opt to allow Independent (no party) voters to vote in primary elections during the following two years. Visit the State Election Board website at <https://oklahoma.gov/elections.html> to find out if any parties allow Independent (no party) voters to participate in their primaries.
- If you write in a political party not recognized in Oklahoma or if you leave your political affiliation blank, you will be registered as an Independent (no party) voter.
- State law prohibits party affiliation changes from April 1 through August 31 of even-numbered years.

**SECTION 6 – RESIDENCE ADDRESS, MAILING ADDRESS, AND COUNTY OF RESIDENCE**

- You must register to vote at your address of residence. Include any house, apartment, or suite number, as applicable. If you have a street address or 911 address, this is your address of residence.
- A rural route or a post office box is NOT an acceptable address of residence.

If you do not have a street address or 911 address, you may write directions to your home or provide the legal description (section, township, range) of the location of your home.

**SECTION 7 – HAVE YOU BEEN REGISTERED BEFORE?**

- If you have been registered before, enter your previous voter registration information.
- Enter your former name if it has changed since you last registered.

**SECTION 8 – ASSISTANCE** If you received assistance with filling out this application, your assistant must provide his or her name and address.

**SECTION 9 – OATH**

**Read the Oath carefully.** By signing the oath, you confirm that you have read, understand, and agree to each statement. Sign and date the oath in ink. If you cannot sign your name, make your mark.

**Who can register** – You can register to vote if you are a citizen of the United States, a resident of the State of Oklahoma, and 18 years old or older. You can preregister to vote in Oklahoma if you are at least 17½, but your registration will not become valid and you cannot vote until you are 18 years old.

**Persons convicted of a felony** may register to vote when they have:

- fully served their sentence of court-mandated calendar days or had their sentence discharged, including any term of incarceration, parole or supervision, or completed a period of probation ordered by any court,
- received a commutation that reduced the sentence of any active felony conviction to time served pursuant to federal or state law and have no other outstanding sentence under any other felony conviction,
- received a commutation pursuant to subsection F of Section 332.2 of Title 57 of the Oklahoma Statutes for a crime that has been reclassified from a felony to a misdemeanor and has no remaining time to serve, including:
  - any incomplete term of incarceration,
  - any remaining parole or supervision, or
  - any incomplete period of probation, or
- been granted a pardon pursuant to federal or state law and have no other outstanding sentence under any other felony conviction.

**Persons judged incapacitated** by a court may not register to vote. The provisions of 26 Okla. Stat. § 4-101 shall not apply to persons adjudged to be partially incapacitated, unless the order adjudging the person to be partially incapacitated restricts such person from being eligible to register to vote.
